1. Introduction

The "HKCTA Coaching Career Programme" aims to identify local potential candidate(s) and offer a clear career development path in tennis coaching. Throughout the whole process of development in about 7-year, we offer a series of ITF Coach Certification courses from elementary (beginner) to development and then advanced (national) level, coaching and travelling opportunities and tutor training in the entire career development process.

2. Eligibility

- 18 to 35 years old;
- Hong Kong permanent resident;
- Completed secondary school education or higher is preferable;
- Former Professional in recent FIVE years; or
- Represented Hong Kong in major events; or
- Former ITF/ATP/WTA ranked player(s); or
- Former Champion or 1st runner-up of National Championships in recent FIVE years in singles; or
- Currently A+ Player in League grading; or
- Have been the member of tennis team in university in recent THREE years.


