### One on One / Focus Training Terms and Conditions

- Booking request must be made at least 35 days in advance and before the application deadlines of each applicable period (the 25<sup>th</sup> of each month).
- The deposit for the requested lesson(s) shall be collected and is non-refundable once the booking is confirmed, the amount shall be deducted from the bill of the total monthly lesson fees by the end of each month.
- The handling fee for each cancellation/ change for each lesson is \$200/hr
- Cancellation/Reschedule:
  1. Training will be cancelled once the typhoon signal No.8 or above is hoisted or in case of inclement weather. Customer should contact the coach one hour before the lesson starts time for the latest training arrangement;  
Should the lesson be cancelled due to inclement weather, lesson will be postponed to another time agreed by the coach and the student. Customer can transfer the deposit to another timing.
  2. For lesson(s) cancelled by student, there won't be a make-up lesson and the deposit is not refundable;
  3. Full lesson fee will be levied if the customers cancel the lesson with less than 24 hours written notice to HKCTA office.
- As deemed required, the HKCTA reserve the right to deploy other coach of equivalent qualifications for conducting the lesson(s) without previous notice.
- Deposit should be sent to HKCTA office within 3 working days after the date of the confirmation email.
- Participants should be dressed in the appropriate tennis attire and should bring along their own tennis racquets.
- The Hong Kong, China Tennis Association will not be liable for any injuries sustained during the training.
- The Hong Kong, China Tennis Association will reserve the right to amend the above items without previous notice.
